# **ACADEMIC REQUIREMENTS (prior to matriculation)**

The following academic standards (including policies for course repetitions) are required of all potential candidates who apply for qualification to the professional phase of the program.\*

- 1. A minimum grade of "C" AND a GPA of 3.0 or better in the specified pre-requisite science courses listed below:
  - a. General Biology I and II w/ Lab (BIO 111 and BIO 112)
  - b. General Chemistry I and II w/ Lab (CHEM 111 and CHEM 112)
  - c. Human Anatomy and Human Physiology w/ Lab (BIO 261 and BIO 262)
  - d. Physics I and II w/ Lab (PHYS 211 and PHYS 212)
  - e. Introduction to psychology (PSYC 100)
  - f. Child & Adolescent Development (PSYC 221)
  - g. Probability & Statistics (MATH 270)
- 2. For LMU UG students only, a minimum grade of "C" in PRS 185 Freshman Seminar in Rehabilitative Medicine and PRS 285 Sophomore Seminar in Rehabilitative Medicine is required.
- 3. For qualification purposes, transfer coursework will be computed into both the pre-professional science GPA and the overall GPA for application into the professional phase of the program. In calculating the pre-professional science GPA, the transfer grade is accepted, and Lincoln Memorial University's credit and quality point systems are utilized.

## **COURSE REPETITIONS**

- 1. Any required pre-requisite courses (Item #1a-g and #2 above) may be repeated. When repeating these courses, a grade of "C" or better must be achieved.
- 2. A student who earns a grade below "C" in any pre-requisite course above (Item #1a-g) may repeat the course at other accredited academic institutions.
- 3. A student who earns a grade below "C" in either courses in Item #2 above (PRS 185 or PRS 285) must repeat that course at LMU.

### **CLINICAL OBSERVATION**

- 1. Prior to matriculation, for qualification to the professional phase of the program, documentation of completion of at least 45 hours of clinical observation exposure is required of all potential candidates through one of the following ways:
  - a. Volunteer work or observation in a Physical Therapy clinic and/or hospital setting under the supervision of a licensed physical therapist
  - b. Employment as a rehab tech or aide in a Physical Therapy clinic and/or hospital
- 2. At the time of application for qualification to the professional phase of the program, students must submit documentation of current completed hours to the Physical Therapy Program using the Clinical Observation Form (found on the Program website). Completion of minimum 45 hours of volunteer work is highly recommended prior to admission.

<sup>\*</sup>A cumulative (encompassing all completed coursework) GPA of 2.8 is highly recommended prior to application.

# **ADDITIONAL REQUIRED DOCUMENTS**

At the time of application for qualification to the professional phase of the program, LMU students must submit the following:

- 1. Three-character references (one must be from a Physical Therapist)
- 2. Personal Statement
- 3. Resume or CV

#### **APPLICATION FOR QUALIFICATION POLICIES AND PROCEDURES**

- 1. Application or reapplication for qualification to the professional phase of the program must be made through LMU's DPT Program on or by a date to be announced annually by the Physical Therapy Program and reviewed at the end of the Fall semester. Applications submitted in prior years will not be considered. Students wishing to be considered in a given year must resubmit an application.
- 2. Students applying for qualification to the professional phase of the program must complete the requirements stipulated within this document by the close of the Spring semester prior to entrance into the professional phase of the program. Official transcripts are required for any transfer coursework completed in fulfillment of pre-professional phase requirements. These transcripts must be issued directly to the Registrar's Office at LMU by the Records office of the institution at which the transfer coursework is completed.
- 3. Students are required to satisfactorily complete the liberal arts core requirements including all pre-professional coursework by the close of the Spring semester prior to entrance into the professional phase of the program.
- 4. Students entering the professional phase of the Guaranteed Professional Admission (GPA) or the Undergraduate "3+3" BS/DPT pathway for the Physical Therapy Program at LMU must be on schedule to complete the requirements for a baccalaureate degree by the end of the first year of the professional phase of the program.

### PLEASE NOTE:

The LMU Bachelor of Science in Exercise and Rehabilitation Science/Doctor of Physical Therapy (BS/DPT) program admissions and progression enrollment related policies can be found on the DPT Program website.

Students in their last pre-professional semester, are advised against completing coursework at other institutions as potential transfer credit because possible delays in receiving official transcripts from the other colleges can postpone the student's acceptance into the professional phase of the program.
