## Two-year Plan <br> Associate of Business Administration (ABA)

The following is a suggested four-year plan of study for freshmen or transfers entering LMU during the 2024-2025 academic year. This plan should be used in conjunction with the University catalog and in consultation with the faculty advisor. Transfer students should contact their advisor if they have questions regarding transfer credit. Courses listed on the two-year plan may be taken during other semesters, based on availability and course placement. This plan meets LMU's general education (Liberal Arts Common Core) requirements and major requirements. NOTE: In order to graduate in two years (four regular semesters) without any transfer credits utilized, the student must average successful completion of $\mathbf{1 5}$ to $\mathbf{1 6}$ credit hours per semester. Please refer to the legend at the bottom of the page for an explanation of superscripts. LMU also requires all first-time freshmen students with less than $\mathbf{1 5}$ credits of college credit to complete UACT 100.
